Phase Three 2nd Chance Reporting Overview

CNYCC will be reopening SELECT RED SCORED activities for the Phase Three funding period

Phase Three 2ND CHANCE Reporting



The re-opening is in response to providing network partners a second opportunity to earn payments for completion of Phase Three Activities

- \$2 MILLION DOLLARS UNEARNED TO DATE

Phase Three 2nd Chance is a RESUBMISSION opportunity ONLY

Opportunity for partners to meet the 80% threshold of activities to unlock performance outcome payments

Phase Three 2nd Chance Reporting

Eligible Activities

2nd Chance Reporting is limited to **SELECT** Activities

- Please refer to your Phase Three Q4 Scorecards
- **RED** Scored Activities

Performance Activities; VBP Readiness Activities; and Actively Engaged Patient reporting are eligible for 2nd Chance Submission
